HFM GALA – THE PREMIERE

Terms and Conditions

HFM Gala – The Premiere (hereinafter the "Gala Event") is a reward offered by HF Markets (SV) Ltd (herein the "Company") to its Clients under the following Terms and Conditions.

1. Introduction

- 1.1. The Gala Event is available to all Clients of the Company who have satisfied the criteria as set out in paragraphs 1.2 and 1.3 of this Terms and Conditions.
- 1.2. In order for a Client to be eligible to participate to this Gala Event he must have opened an approved myHF live trading account with the Company as per the Account Opening Agreement, and he must have completed the age of 18 or the legal age applied in his country of residence or must not be otherwise considered as a 'minor' in his country of residence.
- 1.3. The Gala Event is available only for clients residing in Thailand and Laos.
- 1.4. The Client hereby acknowledges, confirms and accepts to be legally bound by these Terms and Conditions and/or any other legally binding Agreement between them and the Company.

2. Promotion Period

- 2.1. The Gala Event will be hosted on Saturday, 18th January 2025 at UOB Live Emsphere, Bangkok, Thailand.
- 2.2. Registration for the Gala Event is open from the 24th of October 2024 until the 27th of December 2024 at 11:59 pm (TH time). HFM reserves the right to close registration at an earliest date if no more seats are available.

3. Terms and Conditions

- 3.1. Registration for the Gala Event can be achieved through the official website of HFM or through the clients' myHF Area.
- 3.2. The Client enters the Lucky Draw by accepting the Terms and Conditions, depositing and trading during the period from the 24th of October 2024 until the 27th of December 2024 at 11:59 pm (TH time).
- 3.3. Each client agrees that by registering for the Gala Event they express their free, prior and informed consent for the Company to process any personal data which they provide during registration. The data is collected and processed only to such extent, which is necessary to administer and run the Gala Event. The Company shall disclose any data about registrants only to the extent stipulated in these Terms and Conditions. Each registrant has the right to withdraw their consent for processing of personal data at any time. However, such a withdrawal may at the reasonable discretion of the Company result in the disruption, suspension or termination of the client's registration for attending the Gala Event.

4. Specific "Gala Event" Terms

- 4.1 For a Client to be eligible to receive 2 tickets to the night's Lucky Draw and win one (1) VIP seat to the Gala Event, the following requirements must be met:
 - have at least one (1) verified HFM live trading account, with any base currency;
 - deposit a minimum amount of USD 1000 (or currency equivalent) in their HFM live trading account; and

- 5.2 If the Company suspects or has reason to believe that a Client has submitted fraudulent details and/or false identification information during registration for the Gala Event, the Company reserves the right at its absolute discretion to disqualify the Client from this promotion and/or any other promotion offered by the Company.
- 5.3 If the Company suspects or has reason to believe that a Client has abused and/or manipulated in any way any of the Terms and Conditions of the Gala Event and/or any other promotion of the Company and/or has not acted in good faith, the Company reserves the right at its absolute discretion to (i) withdraw and/or withhold any winning prize from the Client and/or (ii) disqualify the Client from this promotion and/or any other promotion offered by the Company with immediate effect.

5.4 If the Company suspects or has reason to believe that a Client has abused and/or manipulated any of the Terms and Conditions of the Gala Event and/or any other promotion offered by the Company, by hedging their positions internally (using other trading accounts held with Company) or externally (using other trading accounts held with other brokers) and/or has not acted in good faith, the Company reserves the right, at its absolute discretion and without obtaining the Client's consent, to remove the Gala Event from the Client's Trading Account or from his winning hedged Account and/or withdraw and/or withhold any winning prize from the Client with immediate effect.

6. Dispute

7. Acknowledgments

- 7.1 Clients acknowledge and confirm that they shall accept responsibility for any taxes that may be incurred as a result of accepting a prize.
- 7.2. By attending the Gala Event, all eligible Clients grant HFM the right to capture their images, likenesses, names, and testimonials through photography, video, or other media. Eligible Clients agree that HFM may use the images, videos, and other media for marketing, promotional, or publication purposes, including but not limited to HFM's website, social media platforms, and other related marketing channels.
- 7.3 By registering and participating in the Gala Event, the Client confirms that he has read, understood and agreed to be bound by the Terms and Conditions of the promotion and any other Terms and Conditions of the Company that may apply.

- 7.6 The Client acknowledges that where the Company has any indication or suspicion of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage connected to a Trading Account or any other forms of deceitful or fraudulent activity, then the Company reserves the right at its sole discretion to:
- (a) Close/ suspend all Trading Accounts the Client has with the Company either temporarily or permanently.
- (b) Void all transactions carried out, including any pending orders and/ or any profits or losses earned.
- 7.7. The Client further acknowledges and understands that where any of the circumstances mentioned in Clause 7.6 above, occur, the Company will not be liable for any consequences on the Prize cancellation.
